Twice as Safe, Twice as Productive by 2020 Progress Report

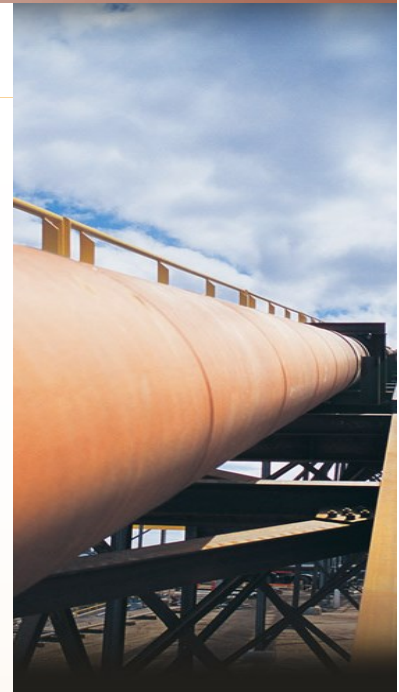

The Industry Leaders Roundtable met in August to review and endorse the Alberta High Level Productivity Metric developed for COAA by CII. The unique feature of this metric is that companies will be able to determine their level of productivity, and dig deeper to find the root causes of low productivity and set improvement goals. The productivity metric was presented to attendees at the 2015 COAA Annual General Meeting.

Communication will be paramount in the roll-out of the High Level Productivity Metric and COAA will work with GO Productivity on this front. Workforce Projections Update



COAA's Workforce Demand Forecasting Committee works hard to analyse and evaluate the many elements which play a role in the demand for workers in the heavy industrial construction sector. Some adjustments have been made to the forecast since the Best Practices Conference in May 2015 due in part to international oil production, the Canadian dollar and market access.

The Canadian Association of Petroleum Producers (CAPP) has recently revised their long term oil production forecast for Alberta from 5 million bpd by 2030 to around 4 million bpd. The impact of the drop in oil prices combined with the drop in the value of the Canadian dollar have also prompted BuildForce Canada to revise their forecast. Their most recent results are now calling for a drop in construction volumes through 2019 with recovery not expected to start until 2020.

Worldwide, the price of oil has caused an estimated \$1.5 trillion worth of oil and gas projects to be considered uneconomical according to a recent report by Wood MacKenzie. But, there is some light at the end of the tunnel. U.S. oil production has started to drop due to less drilling activity. If this drop in production continues, we can expect to see demand start to exceed supply by the third quarter of 2016 and cause the volume of oil in storage to drop. Providing OPEC doesn't increase supply or other major international events upset this course, we should start to see prices rise once the levels of oil in storage decrease to more normal levels;

which, considering the volumes in storage, may take some time.

The amount of activity we are currently seeing in Alberta's construction industry, and will likely see until next year, is largely due to investment decisions made when energy prices were high. This is true for both engineering construction volumes, and for commercial and institutional construction which are currently at high levels in both Edmonton and Calgary. While there remains a considerable amount of maintenance work on major projects, discretionary maintenance and sustaining capital spending is projected to soften until the cash flow recovers. Most new oil sands activity will be smaller incremental in situ projects as opposed to mega projects such as new mines and upgraders.

Shipments of LNG from the newly completed Cheniere Energy Sabine Pass Project in the U.S. are about to start moving and a second project has been approved for production to start in 2018. This will put Canada behind the U.S. in developing LNG markets. In Canada, so far, only one of the 19 proposed projects has received environmental approval and none have committed to start construction.

Understanding Our Canadian Model - An E-learning Experience on the Canadian Model Delivered by Construction Labour Relations — An Alberta Association

In August of 2015 Construction Labour Relations — An Alberta Association (CLR-A) launched an online e-learning program based on the most recent version, v 5.0, of the Canadian Model for Providing a Safe Work Place — Alcohol and Drug Guidelines and Work Rule.

When v 5.0 of the Canadian Model was released, CLR-A saw a need to reach a large number of people quickly with a consistent message on drug and alcohol policy as it is applied in the building trades unionized construction and plant maintenance industries. Having previously offered classroom based learning programs, with over 6000 graduates, online e-learning was the answer to reach construction leaders and administrative staff working at a large number of project locations throughout Alberta.

In order to engage the learner in the learning process, a variety of delivery methods are utilized in the e-learning program including interactive activities, videos, and quizzes. *Understanding Our Canadian Model* addresses all aspects of the Canadian Model policy including the work rule, use of prescription and over-the-counter medications, self-help, alcohol and drug testing, and effective responses to non-compliance with the work rule.

Understanding Our Canadian Model e-learning program is delivered online through BuildForce Canada, who has developed the program and offers technical assistance as needed, under CLR-A direction. The program has been designed for people who have a role in the application of the Canadian Model, particularly front line leaders. Developed in a HTML5 platform, the program can be completed on a variety of devices, including Windows-based computers, Apple computers, and tablets. The completion time is approximately three hours and a certificate is awarded at the end.
